### **Please note:**

Anyone deputising for a member must provide written evidence of his/her power of attorney prior to the Congress.

**Official language:** The official language of the Congress is German.

As in the last years, an interpreter (German/English) will be present at the Congress this year too, who will translate *the general meaning* of the individual agenda items and statements.
